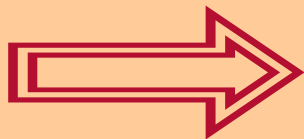

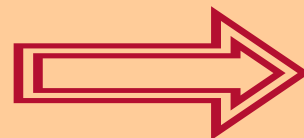
Hotel Accommodations
